## In Brief

### BOS/Warrant Committee

A Warrant Working Group consisting of three Warrant Committee members, the Town Administrator and a BOS member was formed to assess Warrant Committee roles and responsibilities, review budget timelines, resident outreach efforts and messaging content. The goal is to complete the review by December, including identifying and planning next steps.

### Chief of Police Search Committee

Police Chief McGowan will be retiring this month. The seven members of the search committee, along with Russ Stevens of Public Safety Consultants, LLC, the firm hired to assist the Town with this recruitment, met in August to review 30 resumes submitted for the position and chose eleven applicants to move on to the next phase. The Committee will continue to meet in September for applicant review and interviews.

### Community Center Project Update Groundbreaking

The Town of Dover formally broke ground on the long-awaited renovation of the Community Center, the first step toward creating an inclusive, multi-generational building that will serve as a focal point for activities in town.

During the ceremony on August 2, Ford Spalding, Building Committee Chair, thanked the many community members who gave their time and expertise throughout the planning phase, saying “We did not arrive at this day alone.” and “We can all agree, it takes a community to build a community center.” Mr. Spalding also thanked current and past staff members who provided vital support.

Board of Selectmen Chair Bob Springett recognized Community Center members for collaborating with Parks & Recreation and the Council on Aging to make the Center an important part of Dover life. Mr. Springett added that community input played a significant role in guiding the Building Committee throughout the project. “Rather than tell people what we wanted to do, we asked them,” he said. “It’s a spectacular day for the town, and a spectacular day for the community. For Ford and me, this has always been about community, and giving the community options to pursue.”


## Town of Dover Welcomes new Town Planner

## **Lifetime Learning: American Artists and the Landscape on Wednesdays, September 13 & 20, 10:30 a.m. to 12 p.m. in the Community Room of the Dover Town Library**

Instructor: Deborah Stein, PhD, Cost: \$20

American artists have long found the elements of the landscape to provide a rich language for expressing the hopes and fears of their new and developing nation. In this two-session program, explore the work of selected American artists from the early years of the Republic through the turn of the twentieth century. We will set the stage with a glimpse into the landscape tradition in seventeenth through nineteenth-century Europe, examine how these European classical and romantic threads found their way into American artistic production, and consider the impact of factors such as the vast and untamed lands of the American continent as well as burgeoning industrialism and urbanism.

Deb Stein specializes in 18th and 19th-century American and European fine arts and visual culture and in the history of collecting and museums. She holds a Ph.D. from Boston University in the history of art and architecture. Professor Stein is a Visiting Lecturer at the College of the Holy Cross, where she is teaching the history of architecture.

## Pet Waste Pollutes Our Waters

Clean and beautiful water is important to our families, our environment, our economy, and our quality of life. Did you know that animal waste from pets can pollute our waters? When left on the ground or disposed of in a drainage catch basin, pet waste is washed away by rain, melting snow, and ice into storm drains that carry it to our rivers, ponds, lakes, and drinking water. Animal waste contains a high concentration of harmful nutrients, bacteria, and disease-causing microorganisms.



### What You Can Do

Pet owners or pet walkers must properly dispose of the waste by picking it up, wrapping it, and placing it in the trash. Even the toilet isn't the right place for pet waste!

- Never throw pet waste, including used pet waste bags, in a catch basin or storm drain!**

### Dover's Requirements

To protect our waters, the Town of Dover requires that pet owners or their keepers immediately and properly dispose of their pet's solid waste deposited on any public or private property not owned by that person.

Please note that people with assistance animals are exempt.





### **Looking for SHARPS disposal?**

On July 1, 2012, a Massachusetts law went into effect banning the disposal of medical sharps in household waste. Dover residents can bring used needles, syringes, and lancets to the Board of Health office located at the Dover Town House, 5 Springdale Avenue. Sharps should be stored in secure containers (red sharps containers) and can be dropped off anytime during business hours: 8:30-3:30 p.m., Monday-Thursday.





# Planning Board

## Possible Housing Development by Pulte Homes on Junction Street


This summer the Dover Planning Board received a proposal from Pulte Homes for a multifamily development on approximately 17 acres on Junction Street, between the Dover-Sherborn Region campus and Medfield town line. A meeting was held with Pulte representatives, Land Use Department staff and board members, and Planning Board and Board of Selectmen members on Aug. 1. Pulte has submitted an ANRAD application (Abbreviated Notice of Resource Area Delineation) to the Conservation Commission. The Public Hearing on this application will be opened at the Commission's meeting on Sept. 13. The agenda will be posted on the Town Calendar the week of the meeting. Pulte has met with Medfield officials to discuss obtaining water and sewer services from the Town of Medfield.

The August meeting was the beginning of a process that will currently involve the Planning Board, Conservation Commission, Board of Health, Building Inspector, Board of Selectmen and the Department of Public Works. The Planning Board is intent on keeping all interested residents informed. # Conservation Commission

## Protect Dover's Natural Resources with Safe, Chemical-Free Mosquito Control and Organic Lawn Care

The Dover Conservation Commission asks for your help in protecting the Town's environment by using safe mosquito control measures and natural lawn care. Residents like to get out and enjoy their yards without being bothered by mosquitoes, and are concerned about using chemicals that may present safety concerns to their family's health and/or to the environment, including drinking water. The good news is that there are safe, effective, and organic ways to control mosquitoes and other pests in the landscape without the use of chemicals. Before using any chemicals, the Commission encourages residents to learn more about the safe and effective natural mosquito control options that can be found in the following links:

Residents considering hiring a professional service to spray for mosquitoes or other pests on their property are encouraged to first try the safe and effective natural and preventive measures outlined in the links above. Residents who hire a service are encouraged to ask them to use organic, natural treatments. Most companies will provide these services upon request. In addition, it is important to know if the property being treated contains any sensitive wetland areas that need to be protected from chemical exposure, which includes spraying for mosquitoes. The Conservation Commission is charged with protecting the Town's natural resources and is available to help residents with any questions or concerns about protecting wetlands, wildlife habitat and drinking water supply on their property. Residents should contact the Commission if they think there may be wetlands on their property to see if any approvals are needed before having a professional service apply any chemicals on their property. 

## September Recyclable of the month - Invasive Plants

Invasive plant material and grass clippings are not suitable for composting at the Transfer Station. If you are removing invasive plant species, do not bring them to the leaf and yard waste compost pile at the Transfer Station. Composting invasive species can aid in furthering their spread, so put these in the trash:

- Garlic Mustard
- Purple Loosestrife
- Japanese Barberry
- Multiflora Rose
- Winged Euonymus
- Common Reed
- European Buckthorn



Proper disposal of invasive plant parts is important to prevent inadvertently spreading the plants during disposal. Some species can re-root from small cut sections. Some may ripen even after a plant has been pulled. Simply composting in a backyard compost pile will not typically provide enough heat to kill seeds and roots. "Invasive" plants are non-native species that have spread into native or minimally managed plant systems in Massachusetts. These plants cause economic or environmental harm by developing self-sustaining populations and becoming dominant and/or disruptive to those systems.

Compostable Yard Waste (leaves and flowers) is acceptable in the composting area. Prohibited material includes invasive plants, grass clippings, bushes, tree trunks, limbs and stumps or plastic bags.

## Transfer Station Tidbits – Not Just Trash!

Drugs and Medications are a public safety issue leading to accidental poisoning, overdose, and abuse. There is a permanent prescription drug disposal unit in the lobby of the Dover Police Station. No questions asked! Furniture Collections are on the 3rd Saturday of every month for charity.


Food waste from your BBQs and parties, including bones, seafood shells, corncobs and all edibles can be recycled at the transfer station, please bag all items.

Donation bins are always available at the transfer station including Book and Textile recycling for local charities.

## Visit the Recycling Committee at Dover Days

Join the Recycling Committee with their special guest Wade Hayes, our Transfer Station specialist at Dover Days on Saturday, Sept 9. They look forward to greeting everyone and answering any recycling questions you have. There will also be Rain Barrels available for sale. Whether you have an underground cistern or a small barrel by the side of your house, storing rainwater can prevent water from flooding your yard during the rainy season. Be prepared for the next drought!
