Town Meeting:

Our meeting is an Open Town Meeting, meaning all the town's voters may vote on all matters. At Town meeting four major items are decided:

- How money is spent to run the town
- Salaries for elected officials
- Changes to the Town's local statutes, called bylaws
- Citizen's Petitions

We hold our Town Meeting in the New England tradition, which has developed through a combination of custom, statute, and judicial interpretation. On this webpage, you will find a glossary of terms related to town meeting and information about the officials and their duties involved in the process.

The Board is currently collaborating with sponsors and committees to create informative presentations for the Town's website. These presentations aim to educate residents on the various warrant articles, which concluded in mid-January. The Board's objective is to ensure that residents are equipped with a comprehensive understanding of the warrant articles, enabling them to make informed decisions regarding voting.

Water Resource Task Force

The Water Resource Task Force is actively engaged in partnering with CDM Smith to create a comprehensive and detailed Water System Sustainability Report for the Town. To strengthen the report, CDM Smith is simultaneously conducting a study to model the sustainability and resilience of the aquifer, which aims to provide a more in-depth analysis of the water system. These reports, which are anticipated to be comprehensive and insightful, will be available on the Town's website in early March.

Town Budget

The Warrant Committee, the committee responsible for reviewing and approving the town's budget, is diligently examining the budgets of various departments for FY2025. To ensure that they have a comprehensive understanding of the requests, they have been holding weekly meetings with town departments and committees. Their primary focus is on the requests that exceed level services, i.e., the requests that go beyond the basic services offered by the town. The vetting process is rigorous and will continue throughout the month of February, during which time the committee will thoroughly assess each request to ensure that it aligns with the town's overall objectives and budgetary constraints.

Dover Community Center Construction Update

All foundations have been completed for the Community Center Pavilion. The underground conduits and piping for electrical, water, and septic systems have also been completed, as well as backfilling. Gym staging and winter condition protection have been finished. Brick repointing for the 1910 Building is over 50% complete. In February, the pavilion slab will be installed, and steel will be delivered and installed. The gym walls will be completed soon.

On January 11, the Board of Selectmen instructed the Building Committee to proceed with the construction of an enclosed office space near the entrances of the Center for an estimated cost of \$70,000.

Effective February 1, Dick Malcolm will take over as the new Chair of the Building Committee, replacing Ford Spalding. Dick has been involved with the Community Center project for about 20 years and is an experienced building contractor.

Meet the Team

The Board of Selectmen is pleased to announce that Joseph Vinci has been appointed Chief of the Dover Police Department.

Chief Vinci comes to the Town of Dover from the Westwood Police Department where he serves as lieutenant and is the Operations Division commander. Vinci began with the Westwood Police Department as a patrol officer in 2006. He ascended to positions of increasing responsibilities, to sergeant from 2012-2018, to detective sergeant from 2018-2019, and to lieutenant in 2019.

Through his roles in Westwood, Vinci assisted with the department's Massachusetts Police Accreditation Commission (MPAC) accreditation process and helped to bring a Mental Health Clinician to the department. He has managed training for the department's sworn and civilian staff, oversaw Internal Affairs/Professional Standards functions, as well as transitioned the department to a new records management system, scheduling system and policy review system.

Vinci has also served as an instructor at Roger Williams University in Bristol, RI, since 2014, teaching the Field Training & Evaluation Program to sworn officers through RWU's Justice System Training & Research Institute.

Vinci has completed the FBI-LEEDA Trilogy Series. He holds a Master's degree in Criminal Justice Administration from Curry College, a Bachelor's degree in Government from Dartmouth College, and a Certificate in Local Government Leadership and Management from the Massachusetts Municipal Association-Suffolk University.

Vinci was recently appointed as Dover's new police chief on December 14, succeeding Chief Peter McGowan who retired in September. Vinci expressed his excitement and gratitude, stating that he was honored to lead the Dover Police Department. The selection process was rigorous, and the Board of Selectmen appreciated the hard work and diligence of the Police Chief Screening Committee members in ensuring the best candidate for the position was chosen. Chief Vinci began his role as Police Chief in late January.

Primary Election and Special Town Election

Date: March 5, 2024

Polls open at 7:00 AM and close at 8:00 PM

You have some options for voting: in person on Election Day (s); Vote by Mail; Absentee Vote; Early Vote.

1. Vote by Mail

Postcards have been sent out to all voters in Dover by the Commonwealth of Massachusetts. You can fill those in, and ballots will be sent to you automatically. If you request a ballot for every election this calendar year, and you are an UNENROLLED (independent) voter, YOU MUST PICK the ballot you would like to receive for the two primaries! Alternatively, Vote by Mail ballots can be obtained from the Town Clerk's office with a complete vote-by-mail application.

For those who want to vote by mail, you can bring your ballots to the Town Clerk's Office, drop them in the drop box at 5 Springdale Avenue (silver box in the semicircle driveway on Springdale Avenue), or mail them through the post office.

2. Absentee Ballot –

An absentee ballot is essentially the same as voting by mail, with the exception that you can come and vote an absentee ballot in person at the Town Clerk's office during office hours, as soon as ballots are available.

3. Early Voting in Person

at the Dover Town House, in the Great Hall located at 5 Springdale Avenue on the following dates and times:

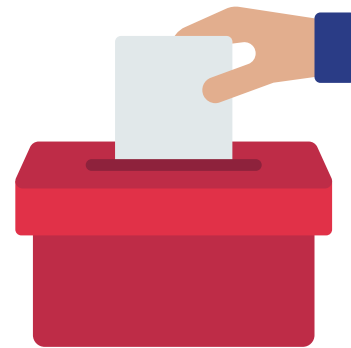

4. Vote in Person

on March 5 at the Dover Town House, in the Great Hall located at 5 Springdale Avenue. Polls open at 7:00 AM and close at 8:00 PM.

To vote in the March 5 election, you must register to vote by no later than Saturday, February 24.

Registration will be conducted at the Town Clerk's Office between the hours of 9:00AM and 5:00PM until February 24. Alternatively, you can register online at:

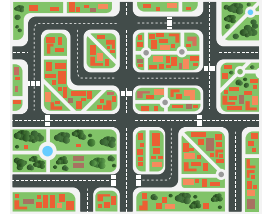
TRAVEL TALK: BHUTAN

Planning Board

The Planning Board is scheduled to convene on February 26, 2024, for a Public Hearing to address several key matters and obtain the public's input. The meeting will take place via Zoom and the link and password will be embedded into the Planning Board agenda available through the town calendar on www.doverma.gov.



Agenda items for the Hearing include:

- **Construction Hours Bylaw Proposal:** At the request of the Building Department, the Planning Board has drafted a Construction Hours Bylaw. The goal of the bylaw is to help reduce noise and disturbance associated with outside construction and provide an enforcement mechanism.
- **Utilization of Funds for Site Plan Review:** Presently, the Planning Board can mandate that sub-division and Special Permit applicants finance external reviews conducted by professional consultants for the Planning Board, relieving the Town of the review's financial burden. With expanded and more complex applications coming before the Board, the Planning Board is considering adding Site Plan Review to the list of permissible applications in Ch 248-26 Review Fees of the Town Code. This approach is pivotal for ensuring efficient planning and development in the community.
- **Approval of Revision to Accessory Dwelling Unit Regulations:** At the Annual Town Meeting in May 2023, the town approved an update to Accessory Dwelling Unit Bylaw. Now, the Planning Board is set to review and vote on a supporting Accessory Dwelling Unit (ADU) regulation which will provide a process and requirements for ADU applications. Your participation in the Hearing is highly encouraged, as your insights will contribute to our informed decision-making process. Recycling Committee

Guidance on Textile Disposal

Did you know that approximately 230,000 tons of textiles are thrown away as trash in Massachusetts each year? It's time to make a change. Rather than tossing your old clothes, blankets, and other textiles in the garbage, consider donating them instead. Not only is it the right thing to do, but it's also the law. Remember, textiles are never trash, and it's illegal to throw them away.

The Dover Recycling Committee would like to thank the residents of the town for recycling 20 tons of textiles in 2023. Let's keep up the good work. All clean and dry textiles, even if they are torn, worn, or stained, can be donated for reuse or repurposing. You can deposit these items in the textile bins located at the Transfer Station and schools.

The used textile industry is substantial. Anything that cannot be sold in retail locations will be sold for other purposes. Here are some tips for recycling textiles:

- Take clothes in "great condition" to a consignment store for sale
- Donate clothes in "good condition" to Circle of Hope, Goodwill, or other organizations
- Recycle clothes in "poor condition" in the textile bins
- Donate towels, tablecloths, and linens in "great condition" to A Place To Turn
- Take towels and sheets in "good condition" to an animal shelter

By recycling textiles, we can cut down on the amount of waste that ends up in landfills. Remember to deposit only dry and odorless clothes in any condition, to help keep our environment clean and safe. Let's work together to make a difference and keep textiles out of the trash.

Transfer Station PSA:

- Did you know that plastic bags and film cannot be recycled at the Transfer Station or with private haulers? You can recycle them at grocery stores instead.
- Please remember that black plastic cannot be recycled, so it's better to reuse it until it must be thrown away.
- Also, please don't put frozen food boxes and waxed milk cartons in the recycling bin. They should be thrown in the trash.
- Lastly, furniture collections for charity take place on the 3rd Saturday of every month.

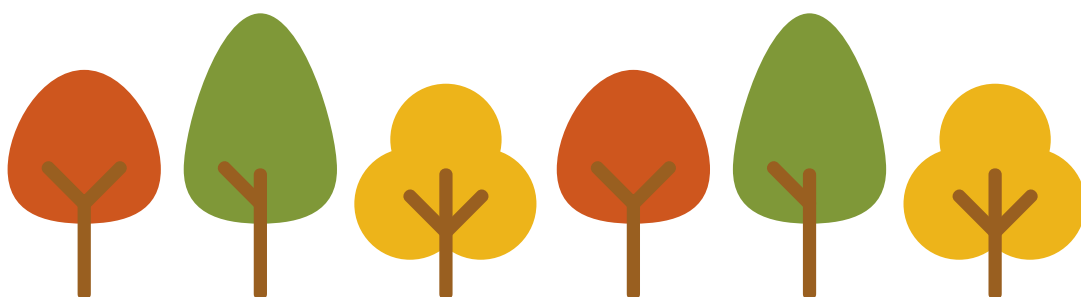

How Wetlands Help Protect Us From Flooding

Wetlands provide us with a number of critical functions and benefits including flood control, prevention of storm damage, prevention of pollution, and preservation of groundwater, drinking water supply and wildlife habitat. They are teeming with life, and provide essential habitats for many animals and many of the plants found in wetlands remove nutrients, such as nitrogen or phosphorus and other pollutants, from the water that can prove harmful.

Due to the ever-intensifying effects of climate change, we are becoming more and more susceptible to extreme weather events including flooding and droughts. The multiple heavy rainfall events that we're experiencing here in Dover are examples of the "new normal" weather conditions we can expect to experience now and into the future. Wetlands play a crucial role in reducing the impacts of more intense rainfall events that result in more runoff, flooding, storm damage, and pollution into our waters. Recharging rainfall into the ground helps remove pollutants and replenishes our groundwater, drinking water supply and our rivers and streams. Wetlands and the trees and other vegetation within them naturally protect surrounding areas from flooding, as they absorb a significant amount of water and temporarily store it—imperative when inundated with excess water. They are therefore also valuable sources of water during periods of drought.

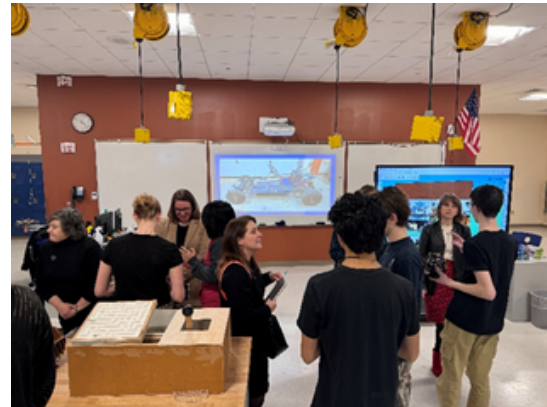

Minuteman High School

Minuteman High School recently had some important visitors, including Secretary of the Navy Carlos Del Toro and a delegation from the British Embassy in Washington DC. They were interested in learning about Minuteman's vocational and academic education programs, as well as its Academy model. The school also recently held its FY25 Budget Hearing, with a total budget increase of 3.96%. Dover's share of the budget will increase by 14.3%. Additionally, a new representative, Maggie Charron, will be joining the Minuteman School Committee. Finally, there is a potential issue in the Massachusetts legislature regarding a lottery admissions system for Vocational High Schools to address the lack of available seats.
