Dover, MA Pipeline Maintenance

Dear Neighbor,

Algonquin Gas Transmission, LLC (Algonquin) is an interstate natural gas pipeline company which operates a natural gas pipeline system with facilities which traverse Dover and Needham. Algonquin constructs, operates and maintains its pipeline facilities under authority from the Federal Energy Regulatory Commission and the Federal Department of Transportation. As part of its obligation under federal law to maintain the safety and reliability of its facilities, Algonquin routinely monitors its pipelines for segments which require attention and addresses issues in a timely fashion to ensure Algonquin's compliance with federal pipeline safety regulations.

As part of its pipeline maintenance program, Algonquin will be excavating and inspecting a portion of its pipeline in Dover where the pipeline crosses the Charles River between Dover and Needham; the work itself will occur in a backwater/oxbow feature on the Dover side of the river. Access to the site will be along a dirt road off Claybrook Road in Dover, near the intersection of Troutbrook Road and Riverside Drive. Work is scheduled to begin in mid-May and take approximately 2 months to complete. Typical work hours will be Monday through Saturday, beginning at 7:00 a.m. and ending at 5:00 p.m. Although the majority of the work will occur within those timeframes, Algonquin wanted to provide you with some additional information in advance of the work beginning which may be helpful. This information has also been shared with your local community.

Keeping the work site dry during the duration of the project requires operating water pumps continuously until the work has been completed. When the construction crew is not on-site, attendants are required to visit the site to manage the pumps to ensure safe operations; that includes Sundays and overnight. For that reason, you may notice flashlights or even a car's headlights at night near the work site as an attendant inspects the pumps.

Although working on Sundays is not currently anticipated, it is possible that work on an occasional Sunday may be necessary to meet the deadline for returning the pipe to service. Failure to meet that deadline could cause supply disruptions for Algonquin's customers.

The most critical part of the project schedule involves the potential need to replace a segment of the existing pipe. All gas is removed prior to that work occurring and the replacement process can take several days. For that reason, Algonquin may find it

necessary to work several continuous 24-hour shifts to complete the work in a timely fashion. In addition to the sound which may be generated, auxiliary lights would be installed to illuminate the work area during that period. If 24-hour shifts are required, this work will occur in early to mid-June.
