Town House Business Hours Change:

The Dover Town House has recently implemented new operating hours in transitioning to a four-day work week. Under this new schedule, the Town House now opens half an hour earlier at 8:30 AM each day and extends its hours until 7:00 PM on Tuesdays. The office is closed on Fridays. Under this new schedule, Town House employees will maintain the same total number of work hours each week but will condense them into a four-day period.

Edible Plant ID Walk

Thursday, July 17, 2025 5:00 PM - 7:00 PM

LOCATION TO BE ANNOUNCED

The Charles River Watershed, which includes the Town of Dover, is home to over 100 species of edible wild plants, some of which are more nutritious and/or flavorful than their cultivated counterparts. These include native species, like Spicebush and Wild Bergamot; non-native weeds, like Chicory and Burdock; and invasive species, like Dame's Rocket, Garlic Mustard, and Japanese Knotweed. Join naturalist and wild food enthusiast Russ Cohen and Charles River Watershed Association staff on a walk to learn about at least 18 species of edible wild plants. Keys to the identification of each of these interesting edible, medicinal, and pollinator species will be provided, along with information on edible portion(s), season(s) of availability, and preparation methods, as well as guidelines for safe, ethical, and environmentally responsible foraging. Attendees should be prepared to walk one mile. The event will occur rain/shine. Remember your bug spray!

The Conservation Commission is charged with protecting and preserving the Town's wetlands, natural resources and open space. We are available to help you with any questions or concerns about protecting our environment. If you think there may be wetlands on or near your property, please contact the Commission to see if any approvals are needed before starting a project or removing any trees. Invasive plants (such as garlic mustard, purple loosestrife, Japanese barberry, multiflora rose, winged euonymus, common reed, and European buckthorn)

CANNOT be disposed of in the compost pile at the Transfer Station. To help curb their continued spread, please bag these invasives and place them in the solid waste/trash containers.

Please join us for a guided walk up Powisset Peak in Hale, as well as the Trustees' Noanet Peak, sponsored by the Dover Open Space Committee (OSC). Note that this is a **longer and more difficult walk than usual**.

On **July 12th**, we will walk through Hale, the Trustee's Noanet Woodlands, and may touch Dover's Larrabee-Whiting Estate. We will sample just a few of a remarkable network of trails that weave through this exceptional open landscape of over 2300 Acres!

This walk will be somewhat steep at times, and parts will be over uneven ground, possibly slippery rocks, so wear appropriate footwear. Bring walking sticks, water, binoculars, and cameras as well as hats, sunscreen, and bug/tick repellent. Polite dogs on leash. Kids welcome! We will stroll in misty rain to shine.

Massachusetts Arbovirus Update

The Board of Health reminds Dover residents to be mindful of mosquitoes when spending time outdoors. The Massachusetts Department of Public Health has announced that West Nile virus has been detected in mosquitoes in Massachusetts for the first time this year.



The time when mosquitoes are most active is dusk and dawn. The tiger mosquito (which has been identified in Norfolk County) is active all day. It is important to wear bug repellent when spending time outdoors. Be sure to regularly empty, throw away, or cover containers that hold water.

Save the Date! MBTA Communities Act Special Town Meeting

Join the Planning Board on September 29, 2025, at 7:00 PM in the Mudge Auditorium of Dover Sherborn High School (9 Junction Street) for a special Town Meeting regarding the MBTA Communities Act. At the meeting, Dover citizens will be asked to vote on a proposed update to the zoning bylaw that would allow multi-family housing by right in a specific overlay district location in Town in compliance with the MBTA communities' Act Requirements. (section 3A, of MGL c. 40A)

A MBTA Public Hearing is scheduled for September 8th at 7 PM. More details will be provided soon.
